OCTOBER PAIRED CONTRADICTORY HYPOTHESIS EVIDENCE TESTING MATRIX Testing the proposition that the mental health profession is an organized criminal enterprise using the following paired contradictory hypotheses. Contradictory hypotheses must meet the logical requirements that both cannot be true and both cannot be false. These are distinguished from contrary hypotheses which have the logical properties that both cannot be true, but both can be false.

E2	Sir Karl Popper, who developed the criteria of testability, refutability and falsifiability for distinguishing science from nonscience adopted by the United States Supreme Court, concluded that Freudian psychological theories were not science: "Such were the reasons, more or less, which led me in 1919 to reject the claims of Freudians, Adlerians, and Marxists that their theories were 'based upon experience' in the same way as were those of other sciences experimental neurology, say, or bio-chemistry. I rejected their claims because I found that their theories failed to satisfy the criterion of testability, or refutability, or falsifiability." E6	Beginning in 1981, the Family Institute of Virginia conducted a two year federally funded experiment to determine the effectiveness of family therapy interventions. Pre and post test measurements were taken on over 3,000 variables for a control group and three experimental groups. The data analysis indicated conclusively that psychological family interventions had no positive effects for any of the three experimental groups. In violation of federal law and the federally funded research contract, these experimental results were never reported. No final report was produced for the funding agency and no warning was issued to the public that psychological family interventions were not effective treatment for family problems.
